

Tusk Lithium Pro Battery Safety Information



PRIOR TO USE, READ AND UNDERSTAND PRODUCT SAFETY INFORMATION AND USER INSTRUCTIONS.

NOTE : Lithium-Ion batteries has different maintenance procedures than Lead/Acid batteries!



Batteries can spark and can potentially ignite when used around areas where flammable fumes are present. Do not try to jumpstart a damaged battery. Do NOT charge with a lead acid charger. Use only approved Lithium Chargers.



Use battery only as intended. Do not leave battery unattended while charging. Do not use battery near flammable sources. Do not puncture, strike, throw, or trample the battery.

In the likely event a lithium-ion battery catches fire, DO NOT attempt to put the fire out with water - use a Class A, B, or C fire extinguisher.



This is an electrical device that can shock and may cause serious injury if handled improperly. Don't wear metallic objects while working on batteries.

Battery Storage

- Store and mount battery in a dry location and keep away from heat
- Do not place the battery in or near fire, exhaust, or other high temperature locations (140+ degrees).
- Keep away from moving parts and contact with any fluid.
- By not following these instructions loss of performance or battery damage may occur and warranty will be void

Tusk offers a Limited Two-Year Warranty for defects in material and/or workmanship.

Conditions which will void warranty

- Opening the battery case
- Applications Not intended by Tusk such as: Aircraft, Automotive, Go Karts, etc.
- Over-voltage charging, incorrect charger used, or other error by charger or user setting of charger
- Damage from faulty Voltage Regulators (overcharging of battery by vehicle)
- Use in excess of cranking (CCA) specifications
- Short circuit of main terminals
- Short circuit caused by improper installation
- Over-discharge (i.e. resting voltage allowed to fall below 12.8V)
- Physical Damage to the battery occurring after purchase (impact, bouncing around in machine, etc.)

Warranty Period

The warranty coverage period will be two years from the original date of purchase. Warranties will only be accepted from the original owner. Any free replacement or pro-rated warranty purchases during this time will not extend the warranty coverage period. A copy of the original receipt or proof of purchase is required for all warranty claims.

Returns & Replacements

Customers are responsible for paying initial shipping charge to return batteries if required. Use a shipping company that is certified to ship Lithium batteries. If battery is damaged, it cannot be shipped. Pictures will be required. Rocky Mountain ATV/MC will pay shipping on replacement batteries sent to customers. Products found NOT defective after in-house testing may be returned to customers, at their expense for shipping. If the battery is found to be damaged, we cannot legally ship it back. It will be disposed of.

The Two-Year Limited Warranty is on a pro-rated basis based from the original date of purchase. Only ONE battery replacement will be given under warranty.

- 1-6 Months — Free Replacement
- 7-12 Months — 75% discount from retail
- 12-18 Months — 50% discount from retail
- 18-24 Months — 30% discount from retail

All returns need preauthorization before shipping.
